Women who are pregnant, People with epilepsy, People with illnesses that are sensitive to light, People using medication or herbal remedies that may result in light sensitivity such as antibiotics, anti-inflammatory drugs, St. John's Wort, etc. Platform Body Vibration training should be omitted after surgery or if you are suffering from cardiac issues, hip and bone diseases, are pregnant, have received bone implants or are suffering from an acute illness or inflammation. If in doubt about whether you should use the Beauty Angel, please seek medical advice prior to use.

Eyewear: The Beauty Angel is not a tanning device, but the lamps emit light energy that is bright in nature. Therefore, we recommend the use of protective eyewear such as Super Sunnies®, Podz™, Wink-Ease®, sunglasses or similar products that limit light transmission while using the Beauty Angel. The eyewear should still allow you to see the control panel and maneuver about the cabin area. You should test eyewear with the unit activated to ensure comfort and safety. The Beauty Angel generates bright visible light that may cause headaches or discomfort for those who are sensitive to such light. You should never stare directly into the light for any reason. **Cosmetics:** Please be aware that makeup may reduce or block the effectiveness of the system. For best results we recommend removing all makeup prior to use. **Medication:** Certain photosensitive medications and cosmetics may increase sensitivity to light. Typically, these products feature a warning label to notify you of potential adverse effects. Please consult with a physician prior to using the Beauty Angel if you are using any such products or medications or have a history of skin problems or believe yourself to be sensitive to light. A list of common photosensitive medications and products should be on display at the location featuring the Beauty Angel.
